As a publicly owned utility, Milford is able to make many of its own decisions about electric and water rates and services. Milford Municipal Utilities are directly accountable to the people they serve through the Board of Trustees appointed by the Mayor. The Board of Trustees and dedicated staff of MMU have many projects that are being considered and/or implemented to make the electric and water services more efficient and reliable. One of the upcoming projects will be the replacement of the electric and water meters. Currently, the meters are read monthly by the MMU staff. Meter reading usually takes two days to collect the readings from the entire community. The new meter system will be read by collector boxes, which will relay the readings to the Utility Office. The new meter system will read the entire community in minutes instead of hours. The expected 20-year life of the meter reading system is an expensive improvement. As with most improvements this one will require MMU to borrow money. The loan payments will require an increase in your water rates. The following letter explains the rate increases.
