**65.01 THROUGH STREETS - STOP.** Every driver of a vehicle shall stop, unless a yield is permitted by this chapter, before entering an intersection with the following designated through streets.

*(Code of Iowa, Sec. 321.345)*

1. Okoboji Avenue (Highway 71) from 4<sup>th</sup> Street to 28<sup>th</sup> Street;
2. 6<sup>th</sup> Street from Okoboji Avenue to H Avenue;
3. 10<sup>th</sup> Street from Q Avenue to H Avenue;
4. 13<sup>th</sup> Street from T Avenue to Airport Drive.

**65.02 STOP REQUIRED.** Every driver of a vehicle shall stop in accordance with the following:

*(Code of Iowa, Sec. 321.345)*

1. 1<sup>st</sup> Avenue. Vehicles traveling west on 1<sup>st</sup> Avenue shall stop at Okoboji Avenue (U.S. Highway 71).
2. 4<sup>th</sup> Street. Vehicles traveling west on 4<sup>th</sup> Street shall stop at Okoboji Avenue.
3. 7<sup>th</sup> Street. Vehicles traveling west on 7<sup>th</sup> Street shall stop at H Avenue.
4. 7<sup>th</sup> Street. Vehicles traveling on 7<sup>th</sup> Street shall stop at Okoboji Avenue.
5. 8<sup>th</sup> Street. Vehicles traveling on 8<sup>th</sup> Street shall stop at Okoboji Avenue.

32. H Avenue. Vehicles traveling south on H Avenue shall stop at 6<sup>th</sup> Street.

63. Airport Drive. Vehicles traveling south on Airport Drive shall stop at 13<sup>th</sup> Street.
64. Alley in Block 1 Meyer's 1<sup>st</sup> Addition. Vehicles traveling north in the alley shall stop at the south property line of Lot 5, Block 1, Meyer's 1<sup>st</sup> Addition.
65. Boji Run. Vehicles traveling north on Boji Run shall stop at Highway 86.
66. Bonnie Lane. Vehicles traveling north on Bonnie Lane shall stop at Chaplin Drive.
67. Bonnie Lane. Vehicles traveling north on Bonnie Lane shall stop at Chaplin Drive Court.
68. Bonnie Lane. Vehicles traveling on Bonnie Lane shall stop at Sportsmans Drive.
69. Chaplin Drive Court. Vehicles traveling south on Chaplin Drive Court shall stop at Chaplin Drive.
70. Chaplin Drive Court. Vehicles traveling east on Chaplin Drive Court shall stop at Chaplin Drive.
71. Chaplin Drive. Vehicles traveling west on Chaplin Drive shall stop at Sportsmans Drive.
72. Chaplin Drive. Vehicles traveling east on Chaplin Drive shall stop at Kuchel Trail.

73. Chaplin Drive. Vehicles traveling east on Chaplin Drive shall stop at Chaplin Drive Court.
74. Chaplin Drive. Vehicles traveling on Chaplin Drive shall stop at 28<sup>th</sup> Street.
75. Chaplin Drive. Vehicles traveling west on Chaplin Drive shall stop at Sportsmans Drive.
76. Clover Lane. Vehicles traveling north on Clover Lane shall stop at 13<sup>th</sup> Street.
77. Delia Court. Vehicles traveling south on Delia Court shall stop at Chaplin Drive.
78. Delia Lane. Vehicles traveling north on Delia Lane shall stop at 30<sup>th</sup> Street.
79. Delia Lane. Vehicles traveling south on Delia Lane shall stop at Sportsmans Drive.
80. Golf Villa Drive. Vehicles traveling west on Golf Villa Drive shall stop at Kuchel Trail.
81. Helen Avenue. Vehicles traveling west on Helen Avenue shall stop at 230<sup>th</sup> Avenue.
82. Hill Drive. Vehicles traveling west on Hill Drive shall stop at 230<sup>th</sup> Avenue.
83. Hill Drive. Vehicles traveling west on Hill Drive shall stop at 340<sup>th</sup> Avenue.
84. Kuchel Trail. Vehicles traveling north on Kuchel Trail shall stop at 202<sup>nd</sup> Street.
85. Marti Drive. Vehicles traveling west on Marti Drive shall stop at Helen Avenue.
86. Parking Lot. Vehicles traveling onto H Avenue from the parking lot located on the grounds of the Okoboji High School shall stop at H Avenue.
87. Pheasant Lane. Vehicles traveling east on Pheasant Lane shall stop at Chaplin Drive.
88. Pheasant Lane. Vehicles traveling west on Pheasant Lane shall stop at Sportsmans Drive.
89. Prairie Lane. Vehicles traveling north on Prairie Lane shall stop at Sportsmans Drive.
90. Prairie Lane. Vehicles traveling south on Prairie Lane shall stop at Pheasant Lane.
91. Prairie Lane. Vehicles traveling north on Prairie Lane shall stop at 30<sup>th</sup> Street.
92. Sportsmans Drive. Vehicles traveling on Sportsmans Drive shall stop at 28<sup>th</sup> Street.
93. Westview Drive. Vehicles traveling north on Westview Drive shall stop at 13<sup>th</sup> Street.
94. Woodlyn Drive. Vehicles traveling west on Woodlyn Drive shall stop at 230<sup>th</sup> Avenue.

95. 6<sup>th</sup> Street. Vehicles traveling east and west on 6<sup>th</sup> Street shall stop at L Avenue. *(Ord. 6-15 – Feb. 16 Supp.)*

96. 6<sup>th</sup> Street. Vehicles traveling east and west on 6<sup>th</sup> Street shall stop at H Avenue. *(Ord. 4-27-2020 – Aug. 20 Supp.)*

97. 19<sup>th</sup> Street. Vehicles traveling west on 19<sup>th</sup> Street shall stop at N Avenue.

98. Vehicles traveling north on N Avenue shall stop at the intersection of N Avenue and 19<sup>th</sup> Street.

*(Subsections 97-98 – Ord. 8-24-2020 – Sep. 20 Supp.)*

**65.03 FOUR-WAY STOP INTERSECTIONS.** Every driver of a vehicle shall stop before entering the following designated four-way stop intersections:

*(Code of Iowa, Sec. 321.345)*

1. Intersection of 7<sup>th</sup> Street and H Avenue.
2. Intersection of 7<sup>th</sup> Street and M Avenue.
3. Intersection of 7<sup>th</sup> Street and N Avenue.
4. Intersection of 8<sup>th</sup> Street and N Avenue.
5. Intersection of 8<sup>th</sup> Street and M Avenue.
6. Intersection of 10<sup>th</sup> Street and Q Avenue.
7. Intersection of 21<sup>st</sup> Street and P Avenue.
8. Intersection of 6<sup>th</sup> Street and Q Avenue. *(Ord. 6-25-11 – Jul. 18 Supp.)*

**65.04 YIELD REQUIRED.** Every driver of a vehicle shall yield in accordance with the following:

*(Code of Iowa, Sec. 321.345)*

1. 4<sup>th</sup> Street. Vehicles traveling east on 4<sup>th</sup> Street shall yield at Q Avenue.
2. 11<sup>th</sup> Street. Vehicles traveling west on 11<sup>th</sup> Street shall yield at J Avenue.
3. 11<sup>th</sup> Street. Vehicles traveling east on 11<sup>th</sup> Street shall yield at P Avenue.
4. 14<sup>th</sup> Street. Vehicles traveling east on 14<sup>th</sup> Street shall yield at P Avenue.
5. 19<sup>th</sup> Street. (Repealed by Ordinance No. 8-24-2020 – Sep. 20 Supp.)
6. 21<sup>st</sup> Street. Vehicles traveling west on 21<sup>st</sup> Street shall yield at N Avenue.
7. M Avenue. Vehicles traveling north and south on M Avenue shall yield at 15<sup>th</sup> Street.
8. Q Avenue. Vehicles traveling south on Q Avenue shall yield at 1<sup>st</sup> Street.

**65.05 SCHOOL STOPS.** At the following school crossing zones every driver of a vehicle approaching said zone shall bring the vehicle to a full stop at a point ten (10) feet from the approach side of the crosswalk marked by an authorized school stop sign and thereafter proceed in a careful and prudent manner until the vehicle shall have passed through such school crossing zone.

*(Code of Iowa, Sec. 321.249)*

1. Intersection of 8<sup>th</sup> Street and N Avenue;

2. Intersection of 7<sup>th</sup> Street and N Avenue;
3. Intersection of 7<sup>th</sup> Street and M Avenue;
4. Intersection of 8<sup>th</sup> Street and M Avenue.

**65.06 STOP BEFORE CROSSING SIDEWALK.** The driver of a vehicle emerging from a private roadway, alley, driveway, or building shall stop such vehicle immediately prior to driving onto the sidewalk area and thereafter shall proceed into the sidewalk area only when able to do so without danger to pedestrian traffic and shall yield the right-of-way to any vehicular traffic on the street into which the vehicle is entering.

*(Code of Iowa, Sec. 321.353)*

**65.07 STOP WHEN TRAFFIC IS OBSTRUCTED.** Notwithstanding any traffic control signal indication to proceed, no driver shall enter an intersection or a marked crosswalk unless there is sufficient space on the other side of the intersection or crosswalk to accommodate the vehicle.

**65.08 YIELD TO PEDESTRIANS IN CROSSWALKS.** Where traffic control signals are not in place or in operation, the driver of a vehicle shall yield the right-of-way, slowing down or stopping, if need be, to yield to a pedestrian crossing the roadway within any marked crosswalk or within any unmarked crosswalk at an intersection.

**65.09 OFFICIAL TRAFFIC CONTROLS.** Every driver shall observe and comply with the directions provided by official traffic control signals at the following intersections:

*(Code of Iowa, Sec. 321.256)*

1. Intersection of 6<sup>th</sup> Street and U.S. Highway 71;
2. Intersection of 10<sup>th</sup> Street and U.S. Highway 71;
3. Intersection of 13<sup>th</sup> Street and U.S. Highway 71;
4. Intersection of Highway 86 and U.S. Highway 71;
5. Intersection of 202<sup>nd</sup> Street and U.S. Highway 71.
